

RECOMMENDATIONS FROM THE CHILDREN'S ADVOCACY EVENT ON CLIMATE CHANGE ON 2 NOVEMBER 2024

To amplify children's and young people's voices in climate discussions at COP, and ensure their views on climate action are considered, Save the Children in partnership with UNICEF Rwanda held a Children's Advocacy Event on Climate Change on 2 November 2024, at Lemigo Hotel, Kigali.

The event brought together children with and without disabilities from eco-clubs, National Children's Forum, refugee camps, and representatives of local and international organizations implementing child rights, environment and climate interventions, UN bodies and government institutions.

Below are the recommendations made by children and other participants from different child-based organizations.

The Right to education for every child should be respected as the school remains the only source of information on environment protection and effects of climate change for children

"Eco-clubs" should be regularly assessed to build their capacity to fulfil their mission.

Gukoresha ikoranabunga mu kuburira abaturage ibiza bitaraba hagashyirwaho n’uburyo bwo kwakira abavuye mu byabo bahunga ibiza	To use technology to create alert systems for the communities at high risk of climate-related emergencies while putting in place temporary shelters for the displaced
Kongera imbaraga mu kwimura imiryango ituye ahashyira ubuzima bwabo mu kaga.	To strengthen the national relocation programme for communities at high-risk areas
Gushora imari mu buhinzi bwihanganira ingaruka z’imihindagurikire y’ibihe mu gihugu hose; ibi bizatuma habaho kwirinda igabanuka ry’ibiribwa mu gihe habaye Ibiza	To invest in climate change resisting crops across the country to prevent food crisis in case of emergencies
Buri gikorwa cyangwa umushinga wo guteza imbere iterambere ry’uburengazira bw’umwana mu Rwanda ugomba kugaragaza uko uzagira uruhare mu kubungabunga ibidukikije no guhangana n’ingaruka z’imihindagurikire y’ibihe.
